Dear Candidate,

- As per the vacant seats in various PG/ME courses at GTU-SET for AY: 2024-25, GTU-SET invited online applications to fill the vacant seats, please find the advertisement and admission schedule of the same.
- You are hereby inform to remain present on **19th October, 2024, Saturday, 10:30 AM** without fail at the institute at your own cost. Any candidate reporting after offer of the admission will not be eligible to claim admission.
- Failure to report and register for admission on the schedule date and time shall result in instantaneous cancellation of the claim of the candidate to the seat.
- The candidate must passed the qualifying examination with minimum eligibility criteria as mentioned in the guidelines of ACPC, GoG.
- **The candidate has to bring TWO set of photocopies of the following testimonials and FIVE (5) passport size photographs: (All original and Set of Xerox copy is MUST)**
 - SSC (10th) Mark sheet and Passing Certificate
 - HSC (12th) Mark sheet (All) and passing certificate
 - Diploma Certificate and All Semester Mark sheet (must including remedial exam if any) [If Diploma Holder]
 - Degree Certificate/Provisional and All Semester Mark sheet (must including remedial exam if any)
 - ACPC Registration/Document verification/Profile Letter - 2024 (Mentioning ACPC Application No./Merit No./Rank No./Rank Type etc. other) (If ACPC registered)
 - PGCET/GATE 2024 Mark sheet/Scorecard
 - School Leaving certificate/Transfer Certificate

- Aadhar Card & ID Proof
 - Category Certificates/Caste Certificates/NCL/Income Certificate etc. other documents as per ACPC & GoG formats (if applicable)
 - Address Proof (if other than mentioned in ID proof)
 - **The candidates who have passed qualifying examination with a mark-sheet having SPI/CPI/CGPA/Grade shall have to produce percentage equivalent certificate issued by concerned university from where they have passed the qualifying examination.**
 - However, for GTU candidates, the conversion formula for CGPA to equivalent % is as per GTU as follows:

$$\% \text{ Equivalent marks} = (\text{CGPA} - 0.5) \times 10$$
- The applicant must present both the **original documents and all the aforementioned testimonials** solely for the purpose of verification. There is no need to submit the original testimonials at the institute.
 - Candidate has to pay Application fee of **Rs. 1000/-** (Only from those who are not in merit of ACPC) at the concerned institute by **Cash only**.
 - In case admission is confirmed, the candidate has to pay **Rs. 13,125/-** (one semester fee) on the same day by **online banking only** (Cheque/Cash is not permitted) as way of confirmation of the admission. Failing to do so, the admission will be treated as cancelled.
 - If any candidate finds it impossible to be physically present for the admission session due to an unavoidable circumstance, he/she can authorize any other responsible individual to represent him/her for the admission process. The representative must carry with him/her a letter of authorization written by the candidate, as well as all the documents required.
 - If the candidate does not remain present as per the schedule date and time, his/her candidature will be treated as cancelled. If the candidate does not remain present at the scheduled date and time and presents after the schedule, he/she will be offered the admission according to seats available and merit at that time.
 - Your admission is deemed to be confirmed if and only if all the formalities of in-person reporting, fulfilment of eligibility, document verification and payment of the fees are completed. Inclusion of name in the merit list does not guarantee the admission to PG Program (Master of Engineering) without the above mentioned process. Allotment of the admission will be strictly on merit and availability of the vacant seats as per ACPC and GoG Norms.
 - Only one parent is allowed with the candidate for in-person counselling.
 - Report at mentioned schedule date and time at **GTU School of Engineering and Technology, Academic Block-5, GTU Chandkheda, Nr. Visat Cross Road, Ahmedabad.**
