Interaction and Feedback

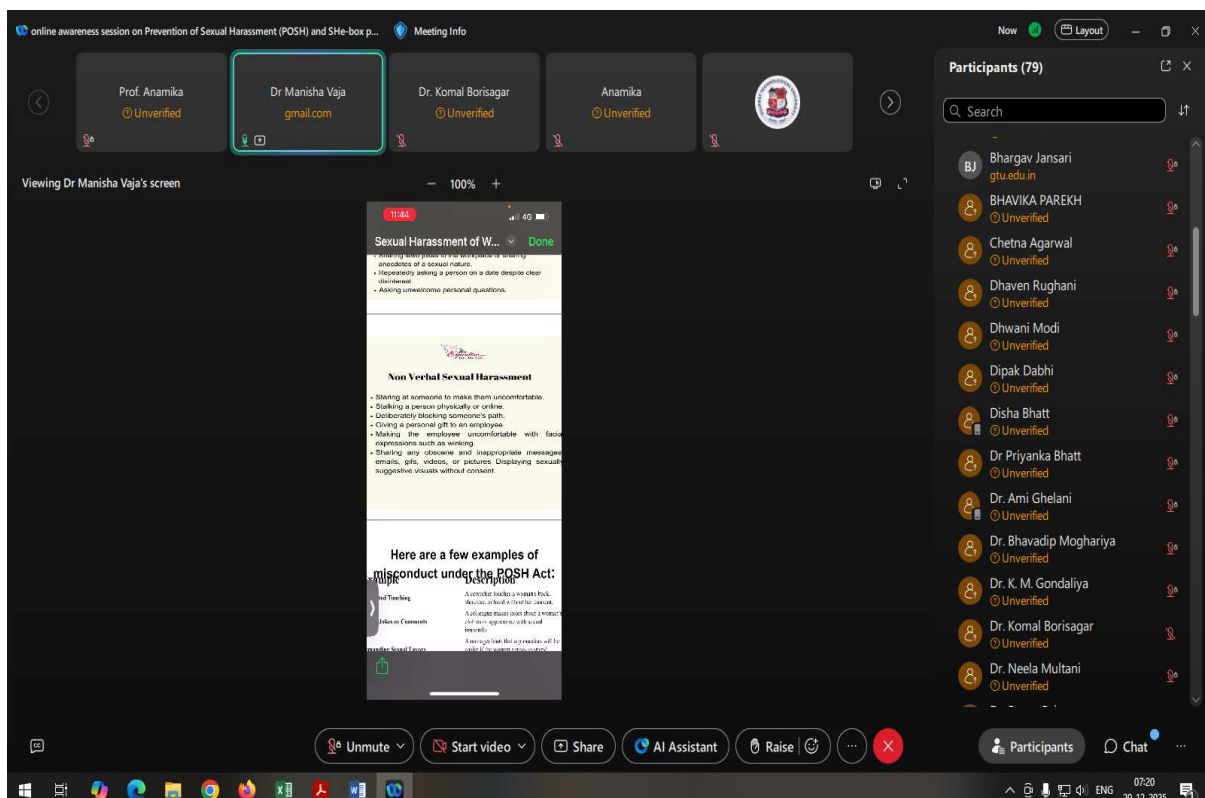
